The regular meeting of the Drake Neighborhood Association board of directors was call to order at the Drake/Des Moines Development Office. Treasurer's Report

The end of the year (December 1986) report was given. Reporting income of \$688.24 and total expenses of \$361.25. Total cash December 31, 1986: 7,231.48. Historic District Application

John Neubauer announced a budget request will be presented on the next board meeting. The historic district application was started many years ago with the Cottage Grove Book on the history of homes in the area. The State Historic Commission came back and said Drake University needed to cooperate and be included in the area. In 1984, the University and DNA began to work together with the creation of the blue book study and Ken Austin organizing the Revitalization Committee. Later, Barb Beving Long was asked to work on the project (half to paid for by DNA and half paid by Drake University). Phase I costed \$400 with phase II costing \$600 (DNA's share in the cost). Now we are going to phase III. (***board members or any member can look at copies of these reports submitted both Phase I and Phase II work***)

COMMITTEES OF THE DRAKE NEIGHBORHOOD ASSOCIATION - JANUARY, 1987

- Beautification The focus of this group is on planting and maintaining of trees, flowers, lawns etc. Projects have included the trees planted on Kingman Blvd., daffodil garden at Witmer Park, flower beds at Drake University and Drake Park. In progress is the Greenspace south of University on Twenty-seventh Street.
- Communication Persons on this committee type and mail the monthly Newsletter. Other members telephone to remind people in the association to come the potlucks, socials, etc. Board members also receive a reminder call prior to each month's meeting.
- Historic The history of the Drake Neighborhood is important not only to residents of the area, but also to the city of Des Moines and to Drake University. This committee helped collect information for the book, "From Keokuk On -- a History of the Cottage Grove Area". The annual Christmas tour of homes is another noteworthy accomplishment of this committee. To date Gladys Burkhead has maintained a scrapbook of the Drake Neighborhood Association as it has evolved into a real force in the community. As the application for historic designation culminates, the need for this group to become involved could take a variety of avenues.
- Housing
- This committee was formed last year and picked Twenty-seventh street as a model project. First came a meeting with residents on the street, followed by a spring clean up. A house was chosen for the association's help with fix-up and painting. Inspection reports were followed on rental properties, and three landlords cooperated by painting properties. Drake University took down two properties and worked with the association in our creating a Greenspace where the houses once stood. The group plans to work on Twenty-sixth Street in 1987 and also on the problems of abandoned houses.


Membership

- The work of the membership committee over the past two years has instituted a membership year (September through August), re-structured the fee schedule, printed a DNA brochure which was distributed door to door in the area, printed and published a membership directory, and maintains a member interest file.* Plans for next year include publishing a new brochure, updating the current directory and putting together a membership map which would mark each association member household.
 - * Names, addresses and other information is stored on computer at Drake University. Drake also provides us mailing labels.

Public/University Relations - The committee is currently working on a slide presentation which we visualize being used by the Association, churches, community groups and realtors as well as Drake University. The purpose is to improve the image of the area and to help publicize the positive aspects of living in the Drake Neighborhood.

Special Events - The committee is visualized as being an umbrella group for the out-of-the ordinary events held by the association such as the Halloween Party, Ice Cream Social, Fallfest, bake sales or whatever kinds of activities the group would like to plan.

Block Organization - Suggestion for adding this committee comes from the officers. Several years ago neighbors got together to organize the Neighborhood Watch groups and to meet each other. This coming year such groups could publicize Neighborhood Housing Services Community Betterment Grants, promote membership, have block parties, etc. It would be one way of creating a small town atmosphere in the middle of a city.



The facilitator led us through a discussion of the above, pointing out that basically our goal was to promote and improve the neighborhood. She then in detail pointed out what to do to accomplish our goal by getting property owners involved by taking on a project as a group; motivating the group; pick out the major uglies; find out who is doing something now; and then re-inforcing what has been done .

Communication - Committee needs an editor for the Monthly Newsletter. Reported by Helen Goodner. <u>Historic</u> - Bricks, bricks and bricks for fixing up brick sidewalks. A number of possible sources have been contacted relative to bricks; the committee will make sure that property owners know about the brick walks; Ken Tharp, a property owner on 26th Street is interested in helping; and Sheffield Brick will assist with technical advice. The Committee also plans a Tour or Tours during the year. Reported by Vicky Malin.
