Drake Neighbors Are Invited to Celebrate With Bernie Lorenz Recovery

Bernie Lorenz Recovery, Inc., is celebrating its 15th anniversary with an open house from 1:30 to 4 p.m. on Sunday, August 7 at their halfway house. Members of the Drake Neighborhood Association are invited to come and join the celebration.

An ongoing silent auction will feature a wide variety of items. Tours of the halfway house residence will be available and refreshments will be served. The program will begin at 3 p.m.

Bernie Lorenz Recovery, a 17-bed residential halfway house for women in recovery from chemical dependency, has served more than 1,000 women during its 15-year history. Since its beginning, it has been located in the Drake Neighborhood – at 4014 Kingman Boulevard. Its mission is to support chemically dependent women living in recovery.

Bernie Lorenz Recovery programs all are focused on helping chemically dependent women remain abstinent, stabilize their lives and develop life skills so they can become

self-sufficient and live healthy, productive lives in successful long-term recovery.

During their 70-90-day stay, all women follow a regimented schedule daily to achieve their individual educational, employment and financial goals - in addition to attending individual and group counseling sessions. Women lacking a high school diploma attend Des Moines Area Community College for tutorial and testing services to complete their GED or to pursue a college degree. Unemployed residents work on obtaining sustainable employment. All of the women learn about basic financial management, about food and nutrition, and about how to access a variety of community resources that will help them remain abstinent, healthy and self-sufficient. When applicable, they also attend parenting classes.

DNA Meeting Minutes: June 8, 2005

Board members present: David Courard-Hauri, Trisha Davis, Dean Blum, Jennifer Lawler, Patti McKee, Eddie Robinson, Jennifer Sayers, Heidi Wessels

1: There were no minutes from the May, 2005 meeting to approve. We hope Bill will get them to us soon.

2: Treasurer's report: Current balance: \$20,956. This includes income from the house tour, but not all expenses yet. The bulb grant money finally came in.

3: NBSD: None present. It was pointed out that a house on 28th and Cottage Grove is open, and the message was relayed to Ed through Dave.

4: New Business: Lauri Laurod of DMPD gave us a quick presentation on the West Side Boxing Club at 611 Forest Ave. It's open M-F 3-7:30 pm, with summer hours 12-6. It is open for kids/adults 12 and up, with 12-17 year-olds needing to be accompanied by an adult. There are generally about 40 people attending on an average night.

a: New Board Members: Dave. We need new Board Members. Hopefully we can have them voted on after the new by-laws are passed. If you know of anyone interested, please let us know. Names mentioned at the meeting were Pam Rothlauf, Lauri Hilgeman, and Eldon McAfee. It was also suggested, as it had been in the past, that Marty Schmitt take the place vacated by her spouse Tony Schmitt. We agreed to discuss it at the end of the meeting after we had Marty leave the room.

b: House Tour Discussion: Derek. Derek commented that he thinks the tour was positive. There are two ways to measure success: quantitatively and qualitatively. Quantitative includes things like how many people came, how much money was made, and so on. From this perspective it was disappointing. However, the qualitative information has not come in yet, because we haven't asked. Derek says he can put together a survey to put into the newsletter and/or online so that we can have more feedback. Looking ahead to 2006/2007, the question is what should we improve. One thing is that every tour we have a chair, who is responsible for *everything*. Derek thinks the house tour needs to expand, to become a big committee (something like 30 members). He thinks the chair should be a Board member, and the committee should be permanent, perhaps with multiple sub-chairs (volunteer chair, finance chair, etc.). There was discussion of these points, with some skepticism directed at the size of the proposed committee, for example. Marty Schmitt said that the first tour was a Christmas tour, and that maybe for the 20th anniversary tour we should do something similar. Lauri Hilgeman and Marty Schmitt volunteered to co-lead the 2006 tour (perhaps with a December 2005 preview). Heidi moved that we accept their offer, with Derek serving in a significant capacity, the motion was seconded by Dean, and it carried unanimously.

c. Jazz in July. Heidi: The Playhouse event will be on July 8. They need membership information and a sign. They also need about \$100 for posters. Heidi moved that the DNA supports both Drake area J in J's: the Playhouse with \$100 and the Drake University event with half of the cost. Trish indicated that last year's J in J seemed expensive, and we agreed to look into that. Trish seconded the motion and it passed unanimously.

5. Old Business:

a. Bylaws: Trish. We need to get by-law suggestions in by late June so that we can vote on them at the next Board meeting and then take the revisions to the quarterly meeting for membership approval.

b. Budget Discussion: Trish. In order to produce a budget, we need everyone to submit requests for what they think their committee will be needing.

8. After the meeting, Marty Schmitt was voted onto the Board to serve out the remainder of Tony Schmitt's term.

I believe that I am leaving at a time when our neighborhoods are experiencing great success and development. It has been outstanding to work with such a group of people who generally care about what happens in their neighborhood. I too hope that I displayed that type of concern while working with you.

My new position will be working in the Research and Development section of the Police Department. My replacement will be Lt. Joanne Pollock. I do hope that you will give her a warm reception and accept her as you did me. My last day in the neighborhood will be Tuesday 12 July 05.
