Chapter 79 revisions

More info available here: https://sites.google.com/site/ch79update2013/ If you are going to download anything from the website listed above, look at the "Chapter 79 with changes and links" that was posted by Larry Bice on September 19. The DE is still in the public comment phase regarding these changes, but the things to look at are not so much the rules changes as the second and third columns of the draft entitled "Guidance to Field (Binding Requirements)" and "Technical Assistance (Suggestions, Examples, Clarification" from the DE, which go well beyond the rules changes. Read the underlined parts from columns 2 and 3 particularly carefully. 79.12(2) A chart or table must illustrate all faculty members' knowledge, experiences, educational preparation aligned with courses taught. Example: an instructor teaching secondary science methods must have preparation and experiences in secondary science teaching. 79.12(5) For faculty members engaged in teacher preparation, activities shall include at least forty hours of teaching at the appropriate grade level(s) during a period not exceeding five years in duration. This requirement applies to all faculty members who teach students or candidates strategies and methods for teaching including planning, assessment, differentiation, instruction, writing curriculum. Examples: math methods and foundations of education classes where lesson planning is taught.

79.13(7) Survey of graduates and their employers. Annual surveys must be conducted.

79.14(7) Student teaching experience. <u>A candidate must complete</u> all preparation and endorsement coursework before student teaching.

Lt. Gov. Kim Reynolds announces Statewide STEM Female Mentoring Effort

(DES MOINES) – Today, Lt. Gov. Kim Reynolds was joined by STEMconnector CEO Edie Fraser, Drake University Athletic Director Sandy Hatfield-Clubb, Iowa Association of Business and Industry President Mike Ralston, and Jana Rieker, Bankers Trust Vice President of Sales and Marketing, at a news conference in the Iowa Statehouse Rotunda. Reynolds announced a national public-private model on ways to engage thousands of mentors for young girls and women to actively pursue STEM (science, technology, engineering and math) education and careers. The first statewide model of its kind, Million Women Mentors (MWM)-Iowa, targets 5,000 female and male mentors from all 99 counties in the next four years.

"Launching MWM-lowa is another component of our statewide-strategy to attract individuals to STEM careers. In particular, I believe mentors can guide, encourage, and open doors for girls and young women to be fully equipped for the great jobs of tomorrow in STEM-related careers."...

... "We know 80 percent of the fastest growing occupations in the United States depend upon mastery of mathematics and scientific knowledge and skills.
