Iowa BoEE/DE updates

Iowa BoEE/DE Updates from the Iowa Association of Colleges of Teacher Education Conference – April 1, 2016

- Program completion exams: ETS Praxis II (pedagogy and content) or edTPA. ETS PPAT is not yet approved. May be approved if a content element is added. Right now it would only assess pedagogy and the content Praxis II test would also be needed.
- Endorsements currently being revised: Reading, Early Childhood
- Licensure recommendation process plans are in the works to update the system to an all online process, no specific date has been set, students will start license application process with the BoEE; May grads will continue under current process.
- Remote fingerprint scanning will no longer be offered by the BoEE for our candidates.
 Programs will each do ink fingerprinting cards for own students. Complete this early in the semester. (FBI can take 4-6 weeks to process the background check).
- Pre-service License discussion is tabled with

- Passing scores for a program completion assessment will be "grandfathered in" for the <u>calendar year</u> if the passing score requirement changes due to recalibration of the 25th percentile.
- Ch. 77 standard updates were approved by the State Board on 3/31/16.
